



- That Nirankari Education Society is a registered trust under the Indian Trust Act.
- That the Nirankari Education Society is a Non proprietary character .
- That the school is being run as a community service and not as a business and the commercialization does not take place in the school in any shape whatsoever
- That no part of income from the institution is being and will be diverted in the Trust/Society/Company /School management committee or to any other recurring and Non -recurring expenditure and contribution to developmental, depreciation and contingency funds will be further utilized for promoting the cause of education in the same school only
- That school is not paying any charges towards using name, motto, logo or any other non academic activities to any other institution .organization or body.
- That the school will not open classes under CBSE patterns particularly class IX/X/XI/XII and will not use CBSE name in any other manner without obtaining affiliation.
- That the Principal and Correspondent /Manager/of the school have individually gone through the provisions obtained in the affiliation and examination byelaws and the circulars issued by the Board from time to time .The school undertakes to abide by the provisions contained in the affiliations and examination byelaws and directions issued from time to time and the law of the land.
- That the school, will ensure compliance of all the statutory requirements like EPF,ESI and labour laws etc. with the respect to the school and staff of the school.
- That the school will ensure that the Building Safety, Fire safety ,Water Safety,Health and Hygeine certificates are being issued or renewed by the concerned municipal or state authorities from time to time per prescribed term.
- That the school will ensure that all the required infrastructure is available with school before starting the classes .
- That the school will ensure that the sufficient number of qualified teachers as per the provision contained in affiliation bye-laws are available with the school before starting classes .
- That the school will follow the provisions related to the fee contained in affiliation bye-laws and will disclose the details of the fee to be students/parents every year before start of session without restoring to any hidden charges in the heads of fee.
- That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.
- That the school shall strive to make efforts for conservation of environment.
- That the school will ensure that the school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all general rules as given in the affiliation byelaws or notified from time to time.
- That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied with all the conditions imposed by CBSE and the post-affiliation conditions contained in affiliation byelaws along with general rules



- That the school will not sponsor students from other board .
- That no member of School managing committee is related to each other.
